## AGREEMENT TERMS FOR NOVITA WORKPLACE LEASING PROGRAM

### TERMS FOR WORKPLACE LEASING PROGRAM

01. The workplace leasing program for NP3302-12M and/or NAS12000 is eligible for Singapore registered businesses only and includes on-site-warranty coverage for the period of the leasing term.
02. Interested businesses can sign up for the workplace leasing program from the novita eStore or at the novita Air.Water.Body Experience Store. Businesses are required to provide a copy of their business certificate of incorporation, or the company representative's NRIC. For signups on the eStore, he/she can email it to leasing@novita.com.sg within 5 working days from the purchase date. For signups at the novita Air.Water.Body Experience Store, he/she can attach it with the filled signup form. An email confirmation will be sent within 5 working days from submitting the required documents.
03. Unit leased is of good working condition and includes a brand new filter set. During the leasing term, a new filter pack will be included yearly and on-site walk-in filter replacement service will be provided by novita. Filter replacement is based on 3,600 litres/1 year usage for NP3302-12M and 6,000hrs/1 year usage for NAS12000. Upon fulfilling the number of filter packs included for the leasing term, the next filter pack will cost \$1 per day for a 5-year term and \$1.16 per day for a 3-year or 1-year term.
04. A 14-day notice period is required for unit return or early termination. Upon early termination, the value of any free gift received will be off-set from the refundable balance and there will be a \$300 administrative fee, covering installation, transportation and unit return services. The refundable balance applies from the next calendar year and will be pro-rated in accordance to the leasing term or number of un-used filter pack, where applicable. Leasing agreement is deemed to be fulfilled with no refundable balance by the leasing end date or when all included filter packs have been installed, whichever comes first.
05. This program is not in conjunction with any other ongoing in-store promotion. Standard novita e-Vouchers are not applicable for this program.
06. User shall not sell, sub-let or mortgage the unit in any situation.

### TERMS FOR INSTALLATION (APPLICABLE FOR NP3302-12M ONLY)

01. I understand that installation should only be conducted by a qualified service technician/installer appointed by novita.
02. I am aware that standard installation must be within 3 meters from a water inlet, 1.5 meters from a power source and cannot be installed on marble, ceramic, glass or concrete table tops due to limitation
03. Standard installation excludes re-wiring of cable, trucking, drilling of concrete & cement wall; as well as non-standard parts like water taps, washer splitter and copper pipes that may be required. If non-standard parts are requested, separate additional cost may apply.
04. All installation works are not reversible, novita will not be liable for any restoration / recovery works after installation.

### TERMS FOR UNIT MAINTENANCE

01. User must notify the appointed technician of any visible defects during installation.
02. Request for exchange on grounds of interior/exterior finishing imperfections will not be permitted.
03. Unless assessed by a novita authorized representative that the unit is operationally defective, the same leased unit will be attached to user for the renewal period, non-withstanding the circumstances.
04. Relocation must be done by a qualified service technician from novita. For NP3302-12M, there will be a service fee of \$160/location and this covers unit collection and re-installation. For NAS12000, there will be a relocation fee of \$100/location.
05. If unit is damaged due to user negligence, the user will be liable to pay for the servicing cost. If the unit is not returned, misplaced or assessed to be beyond repair, it will be deemed as a purchase unit by the user and the top up amount will be advised accordingly.
06. For inspection purposes, user shall permit novita and any personnel authorized by novita to enter the location or premises where the unit is kept.

All information is accurate at the point of print and novita reserves all rights to amend the agreement terms without prior notice.
